



MATERIALS RELEASE FORM

THIS AGREEMENT made for a participation in a short film (“Production”) on or about _____ (“Date”) by _____ (“Producer”) of _____ (“Production Team”) and HHM Film Slam, Hell’s Half Mile Film and Music Festival, Hell’s Half Mile Events affiliates, officers, directors, agents, co-branders or other partners, and any of their employees or volunteers are referenced collectively as “**HHM Collective.**”

The description of the materials described below (collectively “Material”) intended to be incorporated in and used in connection with a short film Production for HHM Film Slam:

1. Material(s) Owner(s) Producer and HHM Film Slam grant permission to incorporate the Material, and any portions or images contained therein, in whole or in part in the Production in any manner at Producer’s sole discretion, and to use and exploit the Material (as incorporated in the Production) in all media, versions and forms, and in any advertising, publicity or promotion for the Production and/or **HHM Collective.** Producer has the right to alter or modify the Material in any manner, at its sole discretion. Producer may in its sole discretion accord credit in the Production and/or otherwise for such use.

2. The Producer agrees and warrants to fix, mend, replace and restore to the original condition all Material(s) as originally loaned.



3. Producer agrees to timely execute and deliver (or to procure the timely execution and delivery of) any additional documents, which **HHM Collective** may require to evidence its rights.
4. The Producer hereby agrees that the Material does not infringe the copyright or violate any right of publicity, privacy or any other right of any person or entity. Producer agrees to indemnify and hold harmless **HHM Collective** from and against any liabilities, losses, claims, demands, costs (including, without limitation, reasonable attorneys' fees) and expenses arising in connection with any breach or alleged breach by me of any above representations or agreements.
5. **HHM Collective** will be entitled to seek injunctive relief in the event of any breach of my representations, warranties and agreements hereunder. **HHM Collective** shall have the right to freely assign and license this agreement and all or a portion of its rights and remedies hereunder, without my consent. This Agreement will be binding upon the parties' respective affiliates, successors, licensees, assigns, heirs and representatives. This Agreement constitutes the entire understanding and agreement of the parties hereto with respect to the subject matter hereof and cannot be amended except by a written instrument signed by the parties hereto.
6. Producer may at any time elect not to use the Materials, in which case neither party will have any obligation to the other hereunder.
