



## MUSIC RELEASE FORM

3. The musical compositions and recordings licensed pursuant to this agreement shall not be distributed or exploited separately or independently of said Production.

4. The term of this license is for all copyrights in and to the musical compositions and recordings in whole or in part, and any and all renewals or extensions thereof that Licensor may now or hereafter own or control.

5. In consideration of the grant of these rights, Producer will properly credit the musicians for music used in the Production.

6. I give Producer the foregoing grant of rights with the full knowledge and understanding that Producer may incur substantial expense in reliance thereon. Producer may at any time elect not to use the Materials, in which case neither party will have any obligation to the other hereunder.



7. I release the Producer, Production Team, **HHM Collective**, their employees, individuals assisting with the Production, agents, assigns, and/or third parties associated with filming locations from all liability which may arise from any and/or all claims by me or any third party in connection with my participation in the Production. I agree to pay for damages to any and all items, property, and/or equipment related to the Production that results from my negligent and/or reckless behavior.

8. It is understood that the Producer is under no obligation to broadcast or distribute the Production. I give the right to the Producer to assign all terms stated in this contract. I also understand that by agreeing to the terms of this contract, I am not guaranteed participation in this Production.
