



TEAM LEADER AGREEMENT

One per Team — Signed by Team Leader — Due at Kickoff

THIS AGREEMENT is made between Team Leader _____,

representing the film team known as _____, (“Team Name”)

and HHM Film Slam regarding the short film being created for this Hell’s Half Mile & Music Festival event scheduled to take place **March 20, 2020** to **March 23, 2020**.

Note: HHM Film Slam (Event), Hell’s Half Mile Film & Music Festival (HHM), Hell’s Half Mile Events, affiliates, officers, directors, agents, co-branders or other partners, and any of their employees or volunteers, are referenced below collectively as “**HHM Collective**.”

- 6 I, Team Leader, have read and agree on behalf of myself and Team to abide by the “Official Rules” presented on www.hhmfilmslam.com and understand HHM reserves the right to disqualify and remove Team’s film from screen and award consideration if film does not adhere to “Official Rules.”
- 6 I, Team Leader, understand I am responsible for all cast, crew, equipment, sets, locations, and other items necessary for participating in the Event, and all related costs, expenses, damages and claims. **HHM Collective** is sponsoring this Event, providing guidelines, a screening opportunity for qualifying films and a prize for the Event winner.
- 6 I, Team Leader, will secure all rights to all material included in the film, including, but not limited to, images, photographs, performances, appearances by any persons, sounds, music compositions, and recordings, and provide signed evidence of these permissions. I represent that I am free to enter into this agreement and that the Team, under my leadership and to the best of my knowledge, will not violate the copyright of any entity; or defame or infringe upon any rights of any kind, including the right of privacy, of any person or entity.
- 6 I, Team Leader, agree to indemnify, defend and hold harmless **HHM Collective** from any expenses, costs, damages, claims, and/or liabilities, including attorney’s fees without limitation, arising from participation in the Event and post-production usage of the production, including but not limited to, all stated above.



- 6 I, Team Leader, understand I shall have full copyrights rights to the created film during this HHM Film Slam event and are free to enter it in screenings, competitions and festivals. We request that the end credits include: **This film was originally created for an HHM Film Slam challenge, www.HHMFilmSlam.com, in collaboration with the Hell’s Half Mile Film & Music Festival, www.HellsHalfMile.com.**
- 6 I, Team Leader, agree to pay for damages to any and all items, property, and/or equipment related to the Production that results from my negligent and/or reckless behavior.
- 6 I, Team Leader, understand that the HHM Film Slam Producer(s) and **HHM Collective** are under no obligation to broadcast or distribute the Production. I give the right to the **HHM Collective** to assign all terms stated in this contract. I also understand that by agreeing to the terms of this contract, I am not guaranteed participation in this Production.
